With reference to your application dated 2-12-86 requesting registration under Foreign Contribution (Regulation) Act, 1976, I am directed to say that your Association has been registered under Sec. 6(1)(a) of the Act and allotted the following Registration No.:

2. You are advised to send intimations within the prescribed time to the Central Govt. of the amounts of each foreign contribution received by you, the source and the manner in which it was received and the purpose for which and the manner in which the foreign contribution was utilised as per the provisions of the FC(R) Act, 1976 and the rules framed thereunder. The association is required to furnish the return even when the particulars are 'NIL'. The Bank Account mentioned in your application should exclusively be for receiving foreign contribution and no other amount should be credited to this account. Any change with regard to the name of the Association, its address, registration aims & objects etc. should be promptly intimated to the undersigned and in case of any of the above changes, fresh registration of the Association under the provisions of the Act will be necessary.

3. You should also ensure before any funds are passed on to any person/association in India that the recipient is eligible to accept foreign contribution under the Act; i.e. (i) recipient association is registered under the Act or has obtained prior permission of the Govt. u/s 6 of the Act and (ii) The person/association is not prohibited under Section 4 of the Act.

4. Failure to comply with any of the above provisions will make you liable for action under the provisions to Sec. 5(1) and/or under Sec. 23(1) of the Foreign Contribution (Regulation) Act, 1976.

5. This Ministry's letter of even No. dated 1-4-1985 may be treated as cancelled.
